

CENTRAL WYOMING FAIR RODETTO

7:30 A.M. – JULY 14 & 15, 2010

1. NO PRCA, WPRA CARD OR PERMIT HOLDERS ALLOWED EXCEPT IN 4D Barrel Race.
2. Only current Wyoming residents allowed in all classes except 4D Barrel Race.
3. Age limit: Age as of July 1, 2010.
4. No two contestants may ride the same horse in the same event.
5. Contestants must run in order shown on program except 4-H exhibitors with conflicting schedules.
6. Contestants can get passes from Mary Strand on July 14th. Only one (1) pass will be issued per person. If lost, an additional pass must be purchased from the Fair Office. You must have your pass to be readmitted to fairgrounds.
7. 100% payback with exception of, NBHA Barrel Race and stock classes. Paybacks will be 40%-30%-20%-10% except for Barrel Race where NBHA Rules will apply.
8. Stalls will be available for Rodetto contestants.
9. A barrel or pole knock down or crossing back across the starting line is a "No-Time."
10. EXHIBITION BARREL RACE – To be held following the 4D barrel race on both days. No Pre-Entries are required. A \$5.00 run charge will be collected at gate prior to each run.
11. KEYHOLE – The pattern is a 20' diameter circle with 4'x10' run. Stepping on or over any portion of the keyhole pattern will count as a "No-Time."
12. GOAT TAIL UNTYING – Goat will be hand held. Contestant may ride, be led on horseback or run on foot. Contestant to pull the ribbon off goat's tail.
13. GOAT TAIL TYING – contestant shall cross the starting line on horseback, dismount at the goat, hand reins to a judge, and tie a ribbon around the tail of the goat. Contestant to raise arms to signal for time to stop. Goats will be hand held for Goat Tail Tying.
14. GOAT TYING – Contestant shall cross the starting line horseback, dismount at the goat and tie any three legs of the goat with a thong or piggin string. Contestant to rise away from goat for time to be stopped. Disqualification shall occur if the contestant's horse touches the goat tether line.
15. No ropes are allowed in Grandstand or on the Midway. Ropes taken into these areas will be confiscated.
16. BREAKAWAY ROPING – Contestants shall have one loop per rope or two ropes with two loops, with a 45 second time limit. Breakaway ropers will start behind a barrier. The barrier must be broken before the rope is thrown.
17. Stock charges will be withheld for goat tying, goat tail tying and breakaway roping.
18. **LIVESTOCK ABUSE WILL NOT BE TOLERATED. SUCH ABUSE WILL BE REASON FOR DISQUALIFICATION, REMOVAL FROM FAIRGROUNDS AND FORFEITURE OF ALL FEES PAID.**
19. Entries shall be mailed to **Mary Strand at 8655 Geary Dome Rd., Evansville, WY 82636. Checks made payable to CWF Rodetto. Must be postmarked by July 1, 2010. Late entries accepted until beginning of event, entry fees doubled, will run at bottom of order.** For further info contact Mary Strand at 307-351-7335 or Julie Gomez at 307-259-0553.
20. Dogs are not allowed on the fairgrounds. Owners are subject to fine and impoundment if animals are at large at any time.
